Selectmen's Meeting November 07, 2016 4:00 pm

A meeting of the Board was held on the above date in the meeting room of Town Hall. Members present were: Margaret E. Serpa, Chairman and Arthur Smadbeck. Also present was Town Administrator Pamela Dolby.

At 4:00pm Ms. Serpa opened the meeting and the first item on the agenda which was a public hearing for an Annual Beer and Wine Common Victualler License for Tin Hangar. Present was owner Brion McGroarty, Manager Jack McGroarty, and Atty. Sean Murphy. Ms. Serpa read the notice aloud.

Mr. Murphy stated that they would like to remain open all year. They will use the Seasonal All Alcohol License in the season and use the Beer and Wine License in the off season.

There being no public comment or correspondence, Ms. Serpa closed the hearing at 4:06pm. Mr. Smadbeck moved to approve the Annual License. Ms. Serpa seconded. Unanimous.

Ms. Serpa then moved on to the next item on the agenda and recognized Police Chief David Rossi. Also present was Officer William Bishop IV.

He really made a difference in these peoples' lives and he wanted to commend Officer Bishop and recognize his actions.

Mr. Smadbeck called him a wonderful example of a Police Officer.

Ms. Serpa stated that his commendation was well deserved.
