Selectmen's Meeting March 2, 2015 4:00 pm

A meeting of the Board was held on the above date in the meeting room of Town Hall. Members present were: Arthur Smadbeck, Chairman; Michael J. Donaroma; and Margaret E. Serpa. Also present was Town Administrator Pamela Dolby.

At 4:00 pm Mr. Smadbeck opened the meeting and recognized Gerry Conover Jr. also present was Robbie Hutchinson and Julia Celeste.

Mr. Conover stated that he was developing the property next to the Town Hall on South Summer St. and they have now received all of their permits and would like to proceed as soon as possible. If they are to open on time they need to stick to a rigid schedule. He was requesting to block of some spaces on the South side of the Town Hall parking lot for demolition for three days March 3rd-5th and on consecutive Saturdays through the end of March for foundation work. The Saturday work would be when Town Hall is closed.
