

**Selectmen's Meeting**  
**April 16, 2013**  
**4:00 pm**

A meeting of the Board was held on the above date in the Fred B. Morgan Jr. Meeting Room, Town Hall. Members present were: Michael Donaroma, Chairman; and Margaret Serpa.

At 4:00 pm Mr. Donaroma opened the meeting and recognized Ms. Barbara Prada, Animal Control Officer.

Ms. Prada gave a print out of her quarterly report and asked if the Board had any questions.

It was remarked that it seemed slow with no surprises.

Ms. Prada agreed.

Ms. Serpa moved to accept the quarterly report. Mr. Donaroma seconded. Unanimous.

Ms. Prada then informed the Board that Ms. Elliot Bennett's two dogs had gotten loose on the day of Town Meeting (April 9, 2013). This was a direct violation of the bonds she posted with the Town. She recommends that the Board vote that Ms. Bennett has violated her bond and forfeits it in the amount of \$400 to the Town, and that Ms. Prada should file a criminal complaint against her in the Dukes County Court of Law.

Ms. Serpa suggested waiting to ask for new bond money until after the complaint had been filed. She moved to file the criminal complaint and forfeit the bond money to the town. Mr. Donaroma seconded. Unanimous.

The Board accepted a letter from Mr. Gerret D. Conover. Mr. Conover was supposed to attend the meeting but submitted a letter instead. The letter had raised some issues with the Port Hunter. The Board decided to invite everyone involved in to discuss the issues.

Mr. Donaroma then recognized Ms. Joyce Hall.

Ms. Hall made some suggestions concerning the Warren House. She thought it would make good senior living apartments.

Mr. Donaroma replied that her idea was good and suggested she find someone to purchase it from the town and develop it. The town has to sell it.

The Board then approved the following items:

To sign the 4th of July Road Permit for the state.

The Rainbow Run on May 11, 2013.

A Craft Fair at St. Andrew's on July 20, 2013.

Common Victualler Licenses for: Morning Glory Farm, Murdick's Café, and Skinny's Fat Sandwiches.

An Innholder's License for the Edgartown Inn.

A Yard Sale Permit for Marge Willoughby and Susan Chapman on 4/27 from 9-4.

A Transient Vendor License for Rags on Dock St.

A Permit to Occupy a Portion of a Public Way to AO Danner on N. Water St. from 8am to noon on 4/17/13.

The Minutes of April 8, 2013.
