# Edgartown Shellfish Committee Tuesday, October 1, 2019, 4:30PM Edgartown Public Library

The meeting was called to order. (*Recorder's Note: discussion has been summarized and grouped for clarity and brevity.*)

### COMMERCIAL, FAMILY, AQUACULTURE LICENSE APPLICATIONS

• IT WAS THE CONSENSUS OF THE EDGARTOWN SHELLFISH COMMITTEE TO AUTHORIZE CHAIR CHRISTIAN THORNTON TO SIGN THE COMMERCIAL SHELLFISHING LICENSE APPLICATION FOR NATE COSTA.

#### CONSTABLE'S & DEPUTIES' REPORT

- Massachusetts Division of Marine Fisheries (DMF) Representative Chris Scallachi reported there might be a fifth case of vibrio from Katama Bay within 30 days, which if confirmed would trigger a 2-week closure, possibly starting Monday, October 7th. Ryan Smith and Nick Turner reported no notification of the 4th case and requested information and/or documentation. Mr. Scallachi was advocating against the closure, and it was noted the case was purchased on Island but transported home privately—a problem that happened annually about this time of year.
- Staff informed the Committee of an incident report on Sandy Fisher's oyster handling (see documents on file). After an anonymous tip, staff found 15 bags of dead and rotting oysters next to the Reading Room wall with tags naming harvest area V20/Blue Ribbon. Mr. Fisher arrived on the scene while the Deputies were collecting the bags and agreed that the oysters were his. Staff explained a number of State and local violations were involved that endangered public health and the livelihood of other aquaculturists:
- shellfish storage in the Harbor closed to shellfishing;
- returning shellfish to the water.

In response to a question on the anonymous tip, staff explained the bags were highly visible and putrid, so they were surprised there weren't more reports. Constable Paul Bagnall advised the Committee to take no action at this point pending State response. In addition it was agreed Sandy Fisher be notified of any pending meeting discussing such local action.

• The Selectmen approved the Committee scallop season recommendation (see 9/17/19 Minutes p. 1-2) but the family season had a poor start with few or no full washbaskets. As agreed at the September 17th meeting the recommendations would be re-examined at the November 5th meeting, when more information was available from the full family season and two days of the commercial season. Staff observed that signs also signaled a poor 2020/21 season.

## Edgartown Shellfish Committee October 1, 2019

- On the other hand quahogs were abundant and staff distributed this year's crop in Cape Pogue and Sengekontacket.
- The Massachusetts Shellfish Initiative (MSI) meeting went fairly well.
- The Shellfish Committee and Department were well represented at the Conservation Commission (ConCom) meeting and the Katama Boat Ramp was approved (see 9/17/19 Minutes p.2).
