- Staff was working on the Major's Cove Oyster Project.
- One aquaculturist had removed all their equipment from the Harbor, however Sandy Fisher was resisting moving back to his plot, despite a verbal warning.
- IT WAS THE CONSENSUS OF THE SHELLFISH COMMITTEE FOR DEPARTMENT STAFF TO PROCEED ACCORDING THE AQUACULTURE INFRACTION PENALTY POLICY (see documents on file).

- Edgartown Great Pond was already fairly high and would be ready to cut again after 2 more big rainstorms. It was very healthy with herring, perch, etc. all fighting to get in.
- \bullet A Vibrio meeting in Vineyard Haven for wholesale dealers promulgated the same regulations as the previous meeting (see 3/15/16 Minutes p. 1).
