MINUTES

• DONALD BENEFIT MOVED TO APPROVE THE MARCH 20, 2012 MINUTES: RYAN SMITH SECONDED: MOTION PASSED UNANIMOUSLY 3 AYES, 0 NAYS, 0 ABSTENTIONS.

• DEPUTIES'/CONSTABLE'S REPORT

- Edgartown Great Pond was opened with two channels Saturday, March 31st and closed within two days having drained but not flushed. Unfortunately this meant diminished herring, and the next opening would have to wait till the Pond filled. It was suggested that next time the dredge cut only one deep channel.
- The engine on the whaler had been repaired and the boat at Sengekontacket would be switched out and repositioned to avoid rocks.
- All oyster bags were finished and delivered to Edgartown Great Pond.

• OLD BUSINESS - Sengekontacket Closure Update

The Division of Marine Fisheries (DMF) took a sample round yesterday and indicated those areas that had tested consistently clean could be opened. It was assumed they would put out markers and keep the Department informed.

• PUBLIC COMMENT

Doug Benefit asked about opening Edgartown Great Pond to clamming with the same dates and limits as last year (see 7/5/11 Minutes p. 1) two level washbaskets three or five days a week. He suggested that all areas be opened so as not to concentrate fishing. The Committee, however, reminded him of the Sanctuary Program and asked that as previously, Doug take one of the Deputies out to survey the Pond (see below: Actions) for fishable areas.

• OLD BUSINESS - Chappy Nursery/Roof Shingles Update

- Roofing was finished Saturday, March 31st. Deputy Warraen Gaines went by Saturday in the rain and found no leaks.
- After brush clearing by the Martha's Vineyard LandBank the building showed the need of some exterior painting and maintenance.
- Ladders were delivered and the wires were being checked.
- -The Committee discussed previous plans for a greenhouse, algae cultivation and the move from a hatchery to a nursery—particularly in view of rumors that an important Cape supplier was closing/changing hands. The Martha's Vineyard Shellfish Group (MVSG) Director Rick Karney was extremely busy with the old Lobster Hatchery project. Wampanoag surplus hatchery equipment had not panned out.
