MINUTES OF THE SPECIAL MEETING OF APRIL 12, 2013

MEETING CALLED TO ORDER:

The Board of Waste Water Commissioners of the Town of Edgartown held a Special Meeting at 2:00 p.m. on Friday April 12, 2013, in the conference room at the Edgartown Waste Water Treatment Facility, located at 330 West Tisbury Road, Edgartown MA 02539. At 2:00 p.m., Chairman James K. Carter called the meeting to order.

NEW BUSINESS:

DISCUSSION/VOTE: REQUEST FOR AUTHORITY TO ABATE LIEN-PARCEL 20D-220, 44 NORTH WATER STREET SIGN WASTE WATER LIEN ABATEMENT CERTIFICATE AND LETTER TO COLLEARY.

Chairman Carter asked Ms. Reed to give a brief description as to why this property got lien. Ms. Reed advised the Commissioners that this property had originally been lien in error in FY11 and the paper worked had been completed and sent to the state to authorize removal of the lien for that year. The approval was granted and the paper work was handed to the Assessor's office so that they would remove the lien. This year Mr. Cannada brought it to the Board's attention that the lien was still on his property. Ms. Reed informed the Commissioners that after some investigation it appears that the original request was not followed thru with and because it was past 6 months since the authorization

had been granted we had to do the process all over again. Chairman Carter asked Commissioner Connelly if he had any questions and was he alright with signing the request and letter. Commissioner Connelly advised the Chairman he was fine with the explanation and he was ok signing the request and letter.

Commissioner Connelly motion that the board wished to allow the abatement of the sewer lien in the amount of \$1,293.60 attached to Edgartown Parcel 20D-220 at 44 North Water Street arising from Sewer Bill FY11-739 sent to Dudley Cannada on December 11, 2012, in addition to interest in the amount of \$222.74; and further, that the Board wishes to ask the Department of Revenue's Division of Local Services to grant the Edgartown Tax Collector permission to abate that sewer lien. Chairman Carter seconded the motion. The motion carried unanimously by voice vote.

ADJOURNMENT:

There being no further business, Chairman Carter asked for a motion to adjourn. Commissioner Connelly offered a motion to adjourn, seconded by Chairman Carter. The motion carried unanimously by voice vote, and Chairman Carter adjourned the meeting at 2:35 p.m.
