## Wintucket Well Update:

## **Amend Computer Article:**

## **PFAS Issue Update:**

Mr. Chapman is pleased with the efforts of the airport on the PFAS issue. However, he'd prefer them to do well filtration and induction rather than treating the individual homes. This method would clean the aquifer so the contamination does not spread to additional homes or our wells.

## **Donaldbin Close Update:**

The applications for town water are being dropped off at wastewater. Once they have all been collected and the water department receives them, the taps will be completed.
