He was told to install the transducer, to show the depth of the ground water available, would be around \$3,000.00. Mr. Lovewell was also interested in a manual for the system. The quote Mr. Ben David received for that was around \$10,000.00.

## Stockyard:

Mr. Lovewell took a ride to the stockyard that is in the progress of being built. He was pleased with the progress.

#### **NEW BUSINESS:**

## **Old Wintucket / CPC:**

Mr. Ben David submitted an application to secure funds to fix up the Old Wintucket pump station. Mr. Ben David will be attending the meeting on October 15, 2014.

## **Clean Well Pump:**

Mr. Ben David stated that each station would cost around \$40,000.00 - \$50,000.00 to clean. Once clean the efficiency in pumping the water will increase. Mr. Ben David would like to concentrate on getting the standpipe painted before having the well pumps cleaned.
