

Selectmen's Meeting

June 8, 2009

4:00 pm

A meeting of the Board was held on the above date in the Fred B Morgan Jr. Meeting Room, Town Hall. Members present were Michael J. Donaroma, Chairman, Margaret E. Serpa, & Arthur Smadbeck. Town Administrator Pamela M Dolby was present.

At 4:00 pm Mr. Donaroma opened the annual merit evaluation for Sharon Willoughby, Town Treasurer. Ms. Serpa abstained from the evaluation.

Mr. Smadbeck spoke of Ms. Willoughby as a benefit to the town and she does a good job keeping up with the finances, not borrowing, and keeping the Town out of financial trouble. Mr. Donaroma agreed.

Mr. Smadbeck moved to give Ms. Willoughby a favorable evaluation. Mr. Donaroma seconded. Unanimous.

At 4:05 pm Mr. Donaroma opened the discussion on an application from Caleb Nicholson to fix curbing at 115 North Water St that had been damaged during some construction on the residence. The work had already been completed, but it being on Town property, Mr. Nicholson needed permission to do the repairs.

Mr. Smadbeck moved to approve the repairs. Mr. Donaroma seconded. Unanimous.

Mr. Donaroma and Mr. Smadbeck agreed.


Ms. Serpa moved to give Mr. Jason a favorable evaluation. Mr. Smadbeck seconded. Unanimous.


Ms. Serpa requested Ms. Dolby set up a meeting with the Board of Trade to discuss employee parking and various other items.

At 4:15 pm Ms. Serpa moved to adjourn. Mr. Smadbeck seconded. Unanimous.


