#### 5) 31 South Water Street Landing – Norman Rankow

Norman Rankow reviewed the changes to accommodate his new boat(s). This involved moving and/or adding pilings and an outboard landing. The Conservation Commission (ConCom) requested a site visit, to which Marine Advisory members were invited if they so chose. This was a congested area and the Committee asked about navigational issues, however, Harbormaster Charlie Blair recused himself from the matter. As this was an old issue:

3) Discussion/Request Cape Pogue Advisory Committee - (See documents on file

(Recorder's Note: This hour-long discussion is summarized and grouped for clarity and brevity.)

• It had come to the Committee's attention that regulations and protections were already in place through:

- the original District of Critical Planning Concern (DCPC) finding--including the outline of a Planning Board generated oversight committee,
- Edgartown Harbor Plan,
- Community Development Plan and
- Zoning Bylaws.

• Enforcement was discussed as primarily from three sources: the Harbormaster, Shellfish Constables and the police boat (with Trustees of Reservation (TTOR) jurisdiction over the shore), however oversight and hierarchy remained unclear.

• Considerable frustration was voiced at the congestion, chaos and damage to Cape Pogue occasioned during the 2020 summer season, due to as many as 162 boats in a day, kiteboarding, drunken parties, jetskis, etc.—the majority of them not from Martha's Vineyard. Edgartown beaches were now struggling with the over-population problems that had been shifting around the Cape and Islands. For example, TTOR's Long Point parking was now by online reservation only.

- A review of previous discussions and minutes could not agree on decided actions.

- Nesting shorebirds restricted previously designated landing areas.
- 'No anchoring' should protect all eelgrass habitat whether eelgrass was present or not.
- The Committee also wished to maintain residents' privilege for quiet use of the Pond.

• The DCPC Oversight Committee had not been formed because previously it was not needed. The correct and transparent public procedure was:

- Marine Advisory Committee meets with Planning Board re: recommended changes to the DCPC Oversight Committee and regulations (see above: Next Meeting);
- Planning Board submits changes to the Martha's Vineyard Commission (MVC);
- changes are voted at Town Meeting; and then
- submitted to the Attorney General's office.

• Everyone was seriously concerned about the 2021 summer and consequently considered simultaneous action on emergency measures.

• BRUCE MCINTOSH MOVED THAT THE MARINE ADVISORY COMMITTEE RECOMMEND TO THE BOARD OF SELECTMEN AND PLANNING BOARD AS AN EMERGENCY MEASURE FOR WILDLIFE AND NATURAL PROTECTION OF CAPE POGUE THAT A LARGE EDGARTOWN TOWN SIGN BE PLACED ON THE BEACH WITH THE TRUSTEES OF RESERVATION PERMISSION SAYING 'HABITAT RESTORATION NO ANCHORING IN ALL OF CAPE POGUE; MARTIN TOMASSIAN SECONDED: MOTION PASSED: 2 AYES, 1 NAY, 0 ABSTENTIONS: MARTIN SKIP TOMASSIAN—AYE, BRUCE MCINTOSH—AYE, ED HANDY—NAY.
