• Although the year was a little better than expected (a couple limits for those willing to put in the time in Cape Pogue) there was not much scalloping going on. Sengekontacket was open for shellfishing. Staff was water quality sampling Sengekontacket Pond, Eel Pond and the Outer Harbor.

• Edgartown Great Pond needed to come up another 4 in. before it could be opened—hopefully in about 2 weeks.

• Shellfish Constable Paul Bagnall would meet with 40 other Constables on Thursday, October 22nd at the Massachusetts Shellfish Officers Association (MSOA).

OLD BUSINESS

Middle Flats

Paul Bagnall confirmed there were 10 Middle Flats/Outer Harbor lots of which 4 were still available. Town Administrator James Hagerty and the Selectmen considered a public hearing on Liam Crossgrove's application sufficient (see 10/5/20 Minutes p.2)-since the area had already been through the approval process. Budget Fiscal Year 2022 (FY22), Town Report, Etc. Calendar

The Town was still reckoning whether summer receipts shortfall would consume Town Free Cash, so department budgets would likely be tight. The calendar was as follows:

• The Martha's Vineyard Shellfish Group (MVSG) applied to all 6 Town Community Preservation Committees to renew intake lines at the Hughes Hatchery, and Paul Bagnall suggested the Chappaquiddick Nursery should be next in line. The Nursery was on a 3-year lease with the Martha's Vineyard Landbank and renewal would carry about \$100,000 in repairs/upgrades.

- In addition he was starting to plan for sea-level rise and was considering significant capital improvements to the point and building for 2025

• The Committee discussed meeting in person outside (as had the MVSG Board of Directors at the Chappaquiddick Nursery) but decided the Zoom platform was fine for the time being.
