- Public Comment Morgan Muir from Edgartown attended as a guest. Background: Experience in solar hot water policy & energy policy in CA, moved into mechanical and net-zero energy. Last 3 years working with Citizens Client Lobby on heat pumps policy, best practices & design. Looking to be of use here on MV.
- 2. October 29 Minutes approved unanimously.
- 3. Energy Audits and Possible Energy Reduction Measures to be Taken
 - a. Contracts almost completed for each building, James to vet and sign off. Alan waiting for contracts to arrive. Ready to move on to implementing the free stuff.
 RISE provided contracts for each building to do the free stuff. Once we get Green Community approved, we can start with the Edgartown School LED replacement.
 - b. Water Dept. also doing heater (not free) 20% and well pump (100%) from CLC.
- 4. Green Community Status
 - a. Stretch code Warrant article to be submitted next week for town warrant, although deadline Jan 6th. Also 100% renewable article to be submitted.
 - b. FY 2020 Baseline Margaret needs help with Packer oil and Vineyard propane for Jan 2020 to present. Carla will follow up with Packer and Vineyard Propane.
- 5. Solar Energy Projects in Edgartown
 - a. Jack, Stephen and Alan meeting with James Jack potential funding through Vineyard Wind via community commitments, learning more about it.
 - b. James wants RFP for consultant services, some candidates identified. James to speak with potential consultants on how to structure RFP for 15K of services. Stephen believes that an RFQ is needed to identify potential consultants. Town asked to convert to RFP problem we don't know what we're shopping for. Concerned about what our next step is, what expectations are. We are not ready to produce RFP since we don't know what the timetables/deliverables would be yet. Jack CH & AQ issued RFP on landfills in the last year, trying to obtain copy of that from Richard. Could be part of solution to RFP issue by providing context. Will follow up with Richard on that. Alan Vineyard Power funding- money issue, no money until end of 2021. Future Fire Dept/Police project could be potential Vineyard Power project.

 - a. Updated pricing small changes to pricing added to chart.
 - b. Alan to run new numbers and submit money article by December 10. Requires attendance at Budget meeting in January.
 - c. James to contact Eversource re: keeping town on 2021 list.
