Sealed Bids for the construction of the "WWTF SCADA System Upgrade" will be received by the Board of Sewer Commissioners at the Edgartown Wastewater Department located at the Wastewater Treatment Facility, 330 West Tisbury Road, Edgartown, MA 02539 until 11:00 a.m. local time on Wednesday October 13, 2021 at which time the Bids received will be publicly opened and read. Please note that overnight and 2-day services do not guarantee timely delivery on Martha's Vineyard. Sealed Bids must have outer envelope marked as "WWTF SCADA System Upgrade".

The work consists of replacement of PLC and SCADA equipment at the Edgartown Wastewater Treatment Facility (WWTF), including PLC hardware, PLC and SCADA software, PLC and SCADA programming, control cabinets, computers, and related electrical work. Five wastewater pumping stations throughout Edgartown shall be upgraded to provide radio communication with the WWTF. Work at each pump stations includes providing a new radio equipment and enclosures as indicated in the bid documents. Bids shall be on a lump sum basis.

All Bids for this project are subject to the provisions of Massachusetts General Laws Chapter 149, Section 44A - 44J inclusive as amended.

In accordance with Section 44D of Chapter 149 of the General Laws of Massachusetts as amended, the prospective General Bidders must submit with their Bid, a certificate of eligibility issued by the Division of Capital Asset Management (DCAM), showing that the Bidder has been approved to bid on projects of the size and nature as advertised herein. Prospective General Bidders must also submit an updated statement summarizing their record for the period between the latest DCAM certificate and the date of the Bid submittal. The DCAM certificate of eligibility to be submitted by the General Bidder shall be for the category of work defined as "Electrical".
