#### **NEW BUSINESS:**

# REPORT/DISCUSS/VOTE: FY22 SEWER USER CHARGES – WARRANT TO COLLECTOR & COMMITMENT NO. 1.

Administrative Assistant Pia Webster reported that she and Department Assistant Jennifer Smith had run the Annual Sewer User Charges Invoices on February 11, with a Date of Billing of February 17. The envelopes had been stuffed and would be left at the post office the following day. The Commitment had come to about \$1.6 million, she said. There being no questions or comments, Commissioner Ellis made a motion to accept the FY22 Sewer User Charges Warrant to Collector and Commitment No. 1, as posted, seconded by Chairman Searle. The motion carried unanimously by show of hand and voice vote.

#### REPORT/DISCUSS/VOTE: FY22 SEWER USER CHARGES – ABATEMENT NO. 1.

Admin Assistant Webster reported that as per usual any annual charges for new sewer accounts that had opened after the first day of the current fiscal year, as well as for accounts that had had an increase in OTDs after July 1, had to be prorated. In the current fiscal year, 20 accounts met the former criterion, and 11 met the latter. These prorations had to be approved through the acceptance of Sewer Abatement No. 1, in the amount of \$9,003.97. There being no questions or comments, Commissioner Ellis made a motion to accept FY22 Sewer User Charges Abatement No. 1, as posted, seconded by Chairman Searle. The motion carried unanimously by show of hand and voice vote.
