The meeting was called to order at 4:32PM. Chair Christian Thornton was traveling and sent his regards. (Recorder's Note: discussion has been summarized and grouped for clarity and brevity.)

NEW CONSTABLE'S & DEPUTIES' REPORT

Scallop Season

About 13 commercial boats were doing well.

Oyster Season

3-4 commercial boats were getting limits, with additional recreational shellfishing. Staff was considering extending the oyster season to April.

NEW BUSINESS

<u>Dredge Committee Katama</u> (See documents on file, & 2/1/22 Minutes p.2 & below: Actions.)

After talking to a number of experienced and elder water people Shellfish Constable Rob Morrison drafted a proposed dredge plan, with tapering banks for the channels from 4 to 6 ft. in the center. There was general commendation for the excellent plan that addressed all the issues and would facilitate the Woods Hole Group (WHG) permit application. Between the application, permitting backlog, engineering, etc. the timeframe was estimated at 5-10 years.

<u>Dredge Committee Edgartown Great Pond</u> (See documents on file, & 2/1/22 Minutes p.2-3.)

- Rob Morrison thanked Dudley Levick for resending his letter which contained some good digestible conversation.
- Dudley Levick corresponded with Martha's Vineyard Shellfish Group (MVSG) former Director Bill Wilcox (email available on request) about his views supporting a schedule of 4 short pond openings, emphasizing his opinions on bio-diversity, freshwater reserves, seepage/evaporation, management for shellfish/financial gain versus Pond health.
- As the dredge was out of the water awaiting repairs, the Great Pond delta would probably not be dredged this year.

- Rob Morrison reviewed Pond management plans dating back to 1934. As an important first step to getting a larger picture of the Pond status and needs, he would tour the Great Pond and its delta with Dredge representatives. He would then consider and take under advisement all the issues including Mr. Levick's along with other expert opinions before planning Great Pond openings.
- The Great Pond Foundation representatives thanked him for looking at and being receptive to the data and appreciated his tour of the Pond.
- Madeline Fisher was on the Town Master Plan Committee and urged Committee members to attend both the Harbor/Waterways and the Business/Economic Development workshops (see below: Meetings/Events); website: www.EngageEdgartown.com

PUBLIC COMMENT

Lionell Spiro ordered oysters from the Martha's Vineyard Fishermen's Wholesale Trust, and stated the wild Edgartown oysters were some of the best he'd ever tasted. He suggested and volunteered to facilitate publicity on Martha's Vineyard oysters like the famous Nantucket oysters on city restaurant menus. (Nantucket Bay oysters might be a matter of branding.) The Committee and staff thanked Mr. Spiro for his compliments and offer.

- There was an objection to the term "wild" oysters since these were Town oysters from the Major's Cove aquaculture farm distributed among the ponds.
