Affordable Housing: Submitted by Arielle Faria:

The Affordable Housing Committee held one meeting in the month of August.

At the August 16th, 2022 meeting the Committee discussed the upcoming hearings for Meshacket Commons, Chairman Hess will be speaking on behalf of the Committee in support of the project. The Committee continued to discuss the potential to increase the AMI of the Trust to 200% in an effort to serve a wider range of people in need of housing on the Island. The research is ongoing. The Committee discussed the potential for Town owned workforce housing, specifically for employees of particular departments.

Room Occupancy and Short-Term Rental Local Option Tax revenues for Dukes County were discussed. The Committee discussed the STR Tax and hopes that a committee will be formed to address the need for a portion of these funds to go towards affordable housing efforts. The Committee approved a letter to be sent to the Selectboard to begin the discussion.

August brought a slight dip in activity in the office relative to sales of properties and requests for Certificates of Compliance and an uptick in applications being processed for hearing in September and October. A longstanding dispute between abutting property appears to have been resolved after years of acrimony and requests to this office for intervention and enforcement. The Agent continued to attend Dredge Advisory, Cape Poge DCPC, and Fishermen's Landing meetings. The Commission was co applicant with the Parks Department for Mass Coastal Zone Management for a grant in the amount of \$1,096,473.60 for a managed retreat and dune restoration for South Beach. The projects goals were to plan for relocation of the guard shack, 2 enclosures for restroom facilities and nourishment and creation of dunes.

Shellfish: Submitted by Rob Morrison:

August 2022 saw license holders participating in a variety of fisheries during the month. As the waters of Edgartown warmed up, and weather improved, the most popular fishery during August was recreational quahogging.

During the month of August, the primary shellfish species harvested commercially were quahogs and steamer clams. A handful of commercial fishermen harvested by hand raking or plunging in areas open to commercial shellfishing. A steamer clam fishery by means of hydraulic harvest also opened during early June in the Edgartown Great Pond. The Edgartown Great Pond commercial steamer clam season ended September 1st.

Recreational fishing for shellfish species including steamer clams, quahogs, and oysters took place in all Edgartown bodies of water open to fishing. Participation in recreational shell fishing saw an increase as the weather improved.

Water Department: Submitted by William Chapman:

- Four water services were installed, with several more applications for service reviewed.
- Monthly bacteriological samples were collected and analyzed.
- Nitrate samples were collected and analyzed, with all samples being compliant.
- Minor leaks were repaired at Lily Pond and Quenomica Pumping Stations. Neither case resulted in damages to the facilities.
- Many trenches from construction projects received final paving.
- Hydrant maintenance (including painting) continues through the summer season.
- The relocated water main at Stop & Shop was placed in service, having passed pressure and bacteriological testing. This project added two fire hydrants to the distribution system.
- The Department Assistant position was filled, bringing the office back to full staff. Heidi Boyd (formerly of the Collector's Office) has transferred to the Water Department. We wish her well with her new position and welcome her to the department.
