Town of Edgartown Selectboard August 28, 2023 4:00 pm

A meeting of the Board was held on the above date in the Fred B. Morgan, Jr. Meeting Room of Town Hall. Members present were: Arthur Smadbeck, Chairman; and Margaret E. Serpa. Also present was the Town Administrator James Hagerty.

At 4:00 pm Mr. Smadbeck opened the meeting and the first item on the agenda which was the MV Beachgoers Access Group. Present was Peter Sliwkowski.

Mr. Sliwkowski started by applauding the efforts of the Parks and Conservation Commission at Norton Point over the summer. He then gave a brief presentation of the issue the group has with the 50yd buffer imposed by the Division of Fisheries and Wildlife. They are asking the Board to join with our State Reps Fernandez and Cyr in opposing this new requirement that hasn't had any public input.

Ms. Serpa moved to have the Town Administrator draft a letter of support. Mr. Smadbeck seconded. Unanimous. They thanked Mr. Sliwkowski for coming in.

Mr. Smadbeck then moved on to the next item which was a letter that the Edgartown Affordable Housing Committee would like to send out to homeowners promoting renting out their properties to the island population and informing them of rental assistance programs.

Ms. Serpa moved to approve and support the letter. Mr. Smadbeck seconded. Unanimous.

The next item on the agenda was the Mass Housing Complete Neighborhoods program, but there was to be a presentation the next day by Zoom at 6:30pm. This made it unnecessary to present at this meeting. The Board moved on to the next item.
