2. FY24 Reserve Fund Transfer:

Request from FinCom Reserve Fund to the School Generator Project, which is \$1,128.00 short. In summary, the bid came in higher, the OPM adjusted their rates down by \$5,000 to absorb some of the overage from the bid and this is the remaining amount. This is needed to be done next week, prior to any major weather events in order is to hook up the school generator system for food services.
