### Committee Members,

I am requesting the sum of twenty-five thousand dollars to fund the removal of the asphalt ramp located at the end of Bailey's Way. I can find no record of this ramp ever being permitted (Chapter 91). Current conditions of the existing ramp are very bad and frankly dangerous to people trying to use it. The Town Highway Department have somehow made repairs to eek by for another season of use. Our plan is to remove this ramp of all asphalt from the high tide mark down so none is in the water. Small vessels would still be able to be launched from the newly restored beach. In future years, if the Town concurs, we can ask the State to fund a small concrete slab ramp.
