The Board of Waste Water Commissioners of the Town of Edgartown held a Special Meeting on Thursday, June 22, 2023, at 3:00 p.m. in the Program Room of the Edgartown Wastewater Facility, 330 West Tisbury Road, Edgartown, Mass. At 3:00 p.m. Chairman Glen S. Searle called the meeting to order. Also present from the Board were Waste Water Commissioner Scott Ellis; Commissioner Walter A. Morrison.

OLD BUSINESS:

Vote: FY24 Sewer User Charge Rates

Having already considered the FY24 Sewer User Charges Rates in their June 15, Regular Meeting, the Commissioners proceeded to vote with little discussion. Due to inflationary pressure and price increases for parts, supplies and label, the expected results of the Comprehensive Wastewater Management Plant, increase flows and loads. For the Annual Review of the Wastewater Sewer Rates for the FY24 the Commission voted to increase the rates, Chairman Glen S. Searle made the following motion: To raise the Annual OTD Rate from \$79.00 per drain to \$81.00 per drain; To raise the Annual BOD Flat Charge from \$1,425.00 to \$1,500.00; To raise the Annual BOD Seat Charge from \$14.25 per seat to \$20.00 per seat over 25 seats. Commissioner Ellis provided a second, and the motion carried unanimously by voice vote.
