Sealed Bids for the construction of the “Town of Edgartown, Edgartown Wastewater Treatment Facility Biosolids Processing & Plant Water System Upgrades Project” will be received by the Board of Sewer Commissioners at the Edgartown Wastewater Department located at the Wastewater Treatment Facility, 330 West Tisbury Road, Edgartown, MA 02539 until 1:00 p.m. local time on Thursday March 14, 2024 at which time the Bids received will be publicly opened and read. Bids may be hand delivered to the Wastewater Plant at 330 West Tisbury Road, mailed via USPS to Edgartown Wastewater Dept, PO Box 1068, Edgartown, MA 02539, or sent via UPS or FedEx to Edgartown Wastewater, 330 West Tisbury Road, Edgartown, MA 02539. Please note that overnight and 2-day services do not guarantee timely delivery on Martha’s Vineyard. Sealed Bids must have outer envelope marked as “Town of Edgartown, Edgartown Wastewater Treatment Facility Biosolids Processing & Plant Water System Upgrades Project.”

Sealed Bids from Subcontractors addressed as referenced above will be received by the Board of Sewer Commissioners at the Edgartown Wastewater Department located at the Wastewater Treatment Facility, 330 West Tisbury Road, Edgartown, MA 02539 until 1:00 p.m. on March 7, 2024 and then at said office publicly opened and read aloud. Bids may be hand delivered to the Wastewater Plant at 330 West Tisbury Road, mailed via USPS to Edgartown Wastewater Dept, PO Box 1068, Edgartown, MA 02539, or sent via UPS or FedEx to Edgartown Wastewater, 330 West Tisbury Road, Edgartown, MA 02539. The work consists of installation of one new dewatering screw press system, installation of a new liquid polymer system in the dewatering room, installation of a new plant water system skid, demolition of existing dewatering room louvers and fans, and installation of new louvers and fans in dewatering room. Bids shall be on a lump sum basis, with additive alternate bid items as indicated in the Bid Form.

All Bids for this project are subject to the provisions of Massachusetts General Laws Chapter 149, Section 44A - 44J inclusive as amended.

In accordance with Section 44D of Chapter 149 of the General Laws of Massachusetts as amended, the prospective General Bidders and Filed Sub-Bidders must submit with their Bid, a certificate of eligibility issued by the Division of Capital Asset Management and Maintenance (DCAMM), showing that the Bidder has been approved to bid on projects of the size and nature as advertised herein. Prospective General Bidders and Filed Sub-Bidders must also submit an updated statement summarizing their record for the period between the latest DCAMM certificate and the date of the Bid submittal. The DCAMM certificate of eligibility to be submitted by the General Bidder shall be for the category of work defined as “Sewage and Water Treatment Plants”. The DCAMM certificate of eligibility to be submitted by the Filed Sub-Bidders shall be for the category of work for which they are submitting a Bid.

Prospective bidders must complete a one-time registration process on the web site in order to receive log-in credentials. Bidders must log in to the web site to download bidding documents for the project. Bidders will be added to the “planholders” or prospective bidders list upon downloading the bidding documents for the project.

A bid deposit shall be furnished in accordance with the Instructions to Bidders.

Minimum Wage Rates as determined by the Commissioner of Department of Workforce Development under the provision of the Massachusetts General Laws, Chapter 149, Section 26 to 27D, as amended, apply to this project. It is the responsibility of the Contractor, before Bid opening, to request if necessary, any additional information on Minimum Wage Rates for those trades people who may be employed for the proposed Work under this Contract.

A non-mandatory pre-Bid conference will be held at the site on Thursday February 22, 2024 at 11:00 am.
