# Key Initiative #1: Zoning Bylaw Updates to Respond to Climate Change

- Worked with Planning Board to submit funding warrant for April 2023 Town Meeting
- Funds were approved by the Edgartown voters to develop zoning bylaw updates, including changes to assist in adaptation to climate change
- The Planning Board created the Zoning Bylaw Review Committee with 5 members
- Climate Committee Chair Julia Livingston elected Chair of the Bylaw Review Committee
- Boston legal expert hired to assist in current bylaw review and to recommend changes
- Planning Board approved submission of 8 zoning bylaw changes for April 2024 Town Meeting
- Public hearing on proposed bylaw changes on February 20 at 5:30 on zoom
- Proposed bylaw changes to be voted on by Town residents during April 2024 Town Meeting

# MVC CAP/Climate Action Plan for the Island

- Published in 2022 and titled "The Vineyard Way"
- MVC Climate Change Coordinator Liz Durkee provided update to the Select Board 12/18/23

# MVC requested the help of all six island town Climate Committees

To communicate with town departments to alert them to the CAP actions which list their departments as partners

# Edgartown Climate Committee Members Met with Town Departments and Committees

The 2023 meetings were follow ups to our 2022 Town Department meetings

- The 2022 meetings with Department Chairs focused on:
  - exploring Department responsibilities relating to climate change
  - o collecting information each Town Department wanted the public to know about what they're doing related to climate change
- The 2023 meetings focused on
  - o discussing CAP actions which list the Department as a partner
  - o learning Department Chair new climate change concerns and program updates



# Key Initiative #2: Alert Town Department Chairs to Specific MVC Climate Actions (cont.)

# Department Meeting Key Findings:

Wastewater Dept

- A Comprehensive Wastewater Management Plan is nearing completion and has a goal of making the entire sewer system resilient to the 100 year flood level plus 3 feet
- Replaced 6 pumps with pumps that use substantially less electric power
- Currently 1300 homes on sewer and 5000 on septic; many could tie into existing sewer but haven't; need to incentivize/provide loans to cover costs
- Sewer removes nitrogen better than any septic, therefore sewer is better for pond and watershed health
- Hope to extend sewer to Sengekontacket watershed in the next 5+ years

Highway Dept

- Repaired and improved stormwater drains and retention areas (key for increased storm intensity)
- Would like to turn suitable undeveloped land into stormwater retention sites that also serve as public open space
- Would like to require wider setbacks and limit how much of a lot can be covered by impervious structures and surfaces
- Need to enforce requirement that property owners prune back hedges to ensure safe sidewalk passage
- Would like to add bicycle parking areas and rework bike routes to avoid heavily trafficked Upper Main Street; recommend a town committee with responsibility for road and bike path signage



# **Department Meeting Key Findings (cont.)**

Shellfish Dept

- Increased storms negatively impact oyster farms and equipment; Norton Point Breach washed away Katama Bay shellfish beds
- Warmer water causing more bacteria impacting oyster industry
- Ocean acidification hinders clam shell calcification resulting in fewer steamer clams
- Importance of oysters/scallops which remove excess nitrogen from our waters

Historic District Commission

• For buildings that are threatened by sea level rise, the Commission does not want to be presented with renovation plans to raise these buildings up above the expected new water levels and would rather see these buildings renovated so that storm surges can wash through the first floor without doing major damage. Building systems should be located on the upper levels of these buildings.

MV Refuse Disposal & Resource Recovery District

- Recycling is sent to Zero Waste in Rochester MA which sorts co-mingled recycling. None of the district's recycling which is sent to Zero Waste is rejected.
- MVRD notes that the \$35 town residents pay for recycling their cans/bottles and paper is a small price to pay for helping to keep our beautiful island sustainable.

# **Climate Change**

2023

#### Edgartown climate actions this year:

- Edgartown voted at Town Meeting to ban the sale of "nip" bottles to cut down on single use plastic and reduce litter across the Island.
- Edgartown voters approved funds to develop and propose updates to the Zoning Bylaw to enable the Town to respond to ongoing climate change.
- Edgartown is now part of the Massachusetts Green Communities program. A Green Communities grant will provide LED lighting at the Edgartown School and contribute to the cost of six new pumps for the wastewater treatment plant, significantly reducing Town electricity use.
- The Town's ranking matrix for capital programs was updated to include a 10% weight value for projects that support climate resiliency.
- A ten acre solar array is in the works at the capped Meshacket landfill. It will generate roughly 4.8 million kilowatt hours of energy per year, saving more than 3,400 metric tons of carbon dioxide emissions.
- Two cables were laid in Edgartown waters east of Chappaquiddick to take electricity from offshore wind turbines to the Massachusetts power grid.





# **Climate Change**

#### Actions you can take:

- REFUSE items which will become trash; REDUCE what you use/ buy; REUSE what you can; RECYCLE what you can't reuse.
- Bring **reusable** shopping bags and recycle clean plastic bags at Stop & Shop.
- **Shop local** to support Island farms, local fisheries, and small businesses and to reduce your carbon footprint.
- Buy a shellfish license and harvest some shellfish.
- Carry a personal water bottle and go to vineyardconservation.org/ tap-map to find FREE water bottle refill stations.
- **Compost** food scraps; don't put grease down the drain; and don't use a garbage disposal.
- Use less water to wash dishes, shower, shave, and brush your teeth.
- Only toilet tissue goes in the toilet; no wipes or personal products.
- Don't idle your vehicle, even for a short amount of time.
- Dispose of fishing gear, balloons, straws, and other plastics properly so they don't end up on beaches or harming ocean wildlife.
- · Ride our electric public buses and bike or walk when possible.
- Keep off dunes and marsh grasses. They provide
- 8- important habitat and protect the Island from storm surges.







# **Climate Change**

#### Actions you can take:

- Shop local to support our farms, local fishers, small ٠ businesses, and reduce your carbon footprint
- Avoid balloons and plastic containers, straws, and ٠ utensils to reduce plastic waste which has to get shipped off Island
- Bring your own reusable water bottles and shopping bags to reduce plastic waste and paper bag waste
- Refill your water bottles at free refill stations located • throughout the Island instead of buying bottled water
- Turn off your car engine instead of idling it to minimize ٠ emissions and save fuel
- Ride bikes and electric public buses and walk when possible to reduce fossil fuel use
- Stay off dunes and marsh grasses because they ٠ protect us from storm surges
- Dispose of fishing gear and single use plastics so they ٠ don't end up on beaches or harming ocean wildlife
- Wash the dishes, shave, and brush your • teeth without keeping the water running to conserve the Island's fresh water
- Take shorter showers to save energy and water
- · Compost food scraps and recycle to reduce waste on the Island



# **Climate Change**

#### Actions Edgartown has been taking:

- Memorial Wharf has been raised two feet
- Inductive chargers have been installed under Church Street so the VTA can transition to all electric buses
- Electric car chargers have been installed at the Park and Ride lot at Dark Woods Road
- The entrances to South Beach and Norton Point have been moved back from the ocean
- Sand has been added to South Beach and the Fuller Street Beach to replenish the dunes
