A meeting of the Board was held on the above date in the second floor meeting room of Town Hall. Members present were: Arthur Smadbeck, Chairman; and Margaret E. Serpa. Also present was the Town Administrator James Hagerty.

At 4:00 pm Mr. Smadbeck opened the meeting and the first item on the agenda which was a transfer of license for Your Market.

Mr. Smadbeck read the notice aloud:

Notice is hereby given, in accordance with the provisions of Chapter 138 of the Massachusetts General Laws and amendments thereto, that Harborside Triangle Liquors, Ltd. d/b/a Your Market, Jamison Loveday, Manager has applied for approval to transfer an annual all alcohol package goods store liquor license to Your Market Liquors MV, LLC, Toniann Belmosto-Borges, Manager. Applicant has also applied for pledge of collateral (License, stock and inventory)

Location of premises: Located at State & Vineyard Haven Roads, Lot #1, the Triangle. Entrance and exit to the same. Wood frame building, first floor enlarged to accommodate groceries. Storage on first floor. Set Floor Plan attached as Exhibit #2.

A public hearing will be held on the application on March 4, 2024 at 4:00 p.m., in the Fred B. Morgan, Jr. Meeting Room, Town Hall, 70 Main Street.

Present were Mr. Loveday and Attorney Frederick C. Grosser.

Atty. Grosser spoke to the application and stated that the business was sold and they would like to transfer the license. The business planned to operate the same as it was currently.
