## Town of Edgartown Selectboard April 1, 2024 4:00 pm

A meeting of the Board was held on the above date in the Fred B. Morgan Jr. Meeting Room of Town Hall. Members present were: Arthur Smadbeck, Chairman; Michael J. Donaroma and Margaret E. Serpa. Also present was the Town Administrator James Hagerty.

At 4:00 pm Mr. Smadbeck opened the meeting and the first item on the agenda which was a Public Hearing for a new Innholders Liquor License for Ring on Hook Faraway MV, LLC d/b/a Faraway Martha's Vineyard, Ty Anthony Accornero, Manager on Kelly Street. Mr. Ty Anthony was present.
