Financial Reports: Munis Report shows good standing no major changes.

But there was a positive email response from the Lodging Association member, stating "As far as I am concerned the 2 other towns currently have the 6% rate so it just brings Edgartown in line with the other towns."

AMI/Maximum Allowable Increase (Amending Trust) Update – It was reported that Town Counsel is still unsuccessful in getting in contact with any attorneys from KP law in regards to how they got Nantucket and Provincetown to go above our 140% maximum allowable(AMI). Ms. Silber suggested that the quickest way would be to go to the Edgartown Zoning bylaw committee KP Law Attorney to get the information. Mr. Smadbeck stated any additional counsel expense must first go through James Hagerty, Town Administrator.
