Town of Edgartown Selectboard June 10, 2024 4:00 pm

A meeting of the Board was held on the above date in the Fred B. Morgan Jr. Meeting Room of Town Hall. Members present were: Michael J. Donaroma, Chairman; Margaret E. Serpa and Arthur Smadbeck. Also present was the Town Administrator James Hagerty.

At 4:00 pm Mr. Donaroma opened the meeting and addressed the first item on the agenda which was an Emergency Sidewalk Repair of 43 Pease Point Way South. Present was Highway Superintendent Allan deBettencourt.

Mr. deBettencourt stated that this house was for sale and the town wanted a commitment to fix the sidewalk that was damaged during construction before it was sold. He asked that the work not be approved to be done until after September 16th.

Ms. Serpa stated that he should be commended. The Board agreed.

The Board approved the weekly warrant.

The Board granted a request from the school to close parts of Robinson Rd. to traffic on June 17^{th} for the School Field Day from 9am-2pm.
