TA James Hagerty reviewed the changes (listed above) and said the increases were a bit higher than expected. With these updates the Total Appropriations for Fiscal Year 2025:

3. ANNUAL TOWN MEETING ARTICLES UPDATE:

a. Wastewater Commission Articles

TA Hagerty explained the [existing] conditions and screen shared the materials from Wastewater to better explain the repair and replacement costs and scope of work; Members asked questions for clarification including how the Comprehensive Wastewater Management Plan (CWMP) would help guide the process.

PAUL PERTILE MOVED TO RECOMMEND THE FULL REPLACEMENT AT \$4,876,000.00. SAID MOTION WAS SECONDED BY JOHN O'HARA. THE COMMITTEE VOTED UNANIMOUSLY IN FAVOR OF THE MOTION: 6 AYES, 0 NAYS, 0 ABSTENTIONS. MR. BAYNES—AYE, MR. COAD—AYE, MS. CUNNINGHAM—AYE, MR. O'HARA—AYE, MR. PERTILE—AYE & MS. TARKA—AYE.

OCEAN HEIGHTS:

PAUL PERTILE MOVED TO RECOMMEND WAITING A YEAR UNTIL THE COMPREHENSIVE WASTEWATER MANAGEMENT PLAN WAS COMPLETED. SAID MOTION WAS SECONDED BY ROBERT COAD. THE COMMITTEE VOTED IN FAVOR OF THE MOTION: 5 AYES, 1 NAYS, 0 ABSTENTIONS. MR. BAYNES—AYE, MR. COAD—AYE, MS. CUNNINGHAM—AYE, MR. O'HARA—AYE & MR. PERTILE—AYE. MS. TARKA—NAY.

b. Conservation Commission "mini-park" lease

Benjamin Hall explained the history/partnership with the Town and how it was designed for tax benefits for his family, how the rent increases were set each year and the insurance implications to his family. Paul Pertile said the Town was currently a Tenant at Will and suggested formalizing the lease going forward. Chair Smadbeck suggested the Conservation Commission continue the conversation with the owners - more work was needed. John O'Hara said that all sides needed to understand the process we were going through, as there were limited resources; we wanted to do what was right for the Town.

JULIA TARKA MOVED TO RECOMMEND ACCEPTING THE ORIGINAL FIGURE AS PRESENTED BY THE CONSERVATION COMMISSION. SAID MOTION WAS SECONDED BY ROBERT COAD. THE COMMITTEE VOTED IN FAVOR OF THE MOTION: 5 AYES, 1 NAYS, 0 ABSTENTIONS. MR. BAYNES—AYE, MR. COAD—AYE, MS. CUNNINGHAM—AYE, MR. PERTILE—AYE & MS. TARKA—AYE, MR. O'HARA—NAY.

c. Zoning Bylaws / Petitions

TA Hagerty explained the process; Members agreed to follow his recommendations.
