2) Alternate Dinghy Dock and Charter Boat Locations

(See Minutes 12/13/17 p.3 #2 & 1/10/18 p.1-2 #3.)

Harbormaster Charlie Blair heard strong objections from fishermen on the previous plan to shift Town pier traffic to relieve summer dinghy congestion (see Minutes: 12/13/18 p.3 #2 & 1/10/18 p.1-2 #3). There was some discussion on his previous stance but the conclusion was to to explore other solutions. The Committee briefly discussed:

- fisherman docking rates;

- possibility of 4 hr. dinghy parking, or no dinghy parking overnight;
- stronger enforcement re: long term dinghy tie-ups and unregistered dinghies;
- floats on the stake field to the west of the Reading Room; and
- development of Chappaquiddick Gardiner property for boats and dinghies possibly including free On-Time Ferry tickets to users.

a) Mooring Regulations Amendment Discussion

The regulation draft was ready (see 2/22/17 Minutes p.3 #4 & below: Actions).

c) Harborside/Edgartown Waterfront Access Court Case

The Town of Edgartown prevailed over the Harborside Hotel but the Judge had not yet issued a written decision.

4) Harbormaster Update

• Transient dockage opened February 15th and sold out the summer in 2 hours, through Dockwa with everything paid up front –part of the continuing Town trend to eliminate cash transactions. (Harborside, Mad Max Oak Bluffs, Tisbury Wharf and Nantucket were also now using Dockwa.)

- Mooring reservations would open March 1st.
