Chair Gary Look opened the meeting and asked that all cell phones be placed on vibrate and that any calls be taken out of the meeting room.

### 1) Mad Max Marina, Ongoing Discussion, Agent Barbini

(The previous meeting was canceled due to snow.) In terms of previous suggestions, (see 1/8/14 Minutes) Mr. Barbini explained that a 10 ft. extension was not enough to produce any substantial difference and also that the existing 8 ft. wide pier could not be effectively narrowed. The pier would still have to be rebuilt and the request was still to extend or expand it. The project was explored again.

- The existing Army Corps of Engineers channel was quite deep (27-36 ft.).

- The Faired Pier line, sight line and encroachment line were all discussed.

- The issue continued to be the beam of the boats that would be moored on the end of the extended pier. An offer to restrict the size of boats tethered to the end would be the purview of the Planning Board. On the other hand it was not the wish of the Advisory Board to create another enforcement situation.

- It was clear the dock needed more space but more space was not available at the location. Alternatives such as expanding the interior, adding a square or opening the "pincers" were explored but proved impracticable due to public access issues.

- 15 ft. would be optimum but any extension would be an improvement.

- Gary Look sited the expansion as in conflict with the Harbor Plan p. 127 Section 1 and p. 128 Section C7 "not allowed to interfere with navigational channels". Skip Tomassian agreed.

- Bruce McIntosh had originally suggested a reduction to a 10 ft. expansion but now thought even that might be too much because it would impede access to and from dockage on both sides.
