

Edgartown Planning Board Minutes

Tuesday, June 12, 2020

A regular meeting of the Edgartown Planning Board was scheduled for Tuesday, June 12, 2020, at 10:00 AM. Pursuant to the Governor's order of March 10, 2020, and Chapter 53 of the Acts of 2020, the meeting was conducted with 100% remote participation for all members, applicants, and the public.

The meeting was audio and video recorded, with attendees participating by video conference.

All supporting materials that had been provided to the members of this body were available on a publicly accessible internet website. Any member of the public was able to access the site, using the instructions included in the Meeting Agenda.

The board continued a public hearing related to a Definitive Subdivision Plan to subdivide 30.75 acre +/- lot into four conforming lots to serve the Town of Edgartown's Recreation Area, the Town of Edgartown's New West Side Cemetery, and the Boys and Girls Club. Plan will extend M. Daniels Way to serve the lots.

Mr. Finn provided an update of the MV Commission referral process, and noted that the proposal had been taken up as a full DRI. Mr. Finn noted that the applicant was not present to make any presentation or provide new information. No public testimony was taken.


