There being no further business, it was MOVED by Sherman, SECONDED by Mascolo


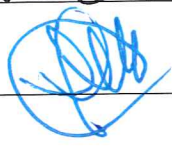
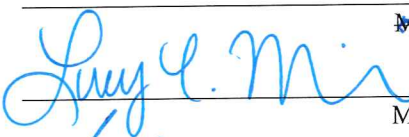
