

Selectmen's Meeting
August 5, 2019
4:00 pm

A meeting of the Board was held on the above date in the meeting room of Town Hall. Members present were: Margaret E. Serpa, Chairman; Arthur Smadbeck and Michael J. Donaroma. Also present was Town Administrator James Hagerty.

At 4:00pm Ms. Serpa opened the meeting and the first item on the agenda which was the Town Bar & Grill to request permission for outdoor entertainment. Present was Tim Starzyk, Manager.

Mr. Starzyk explained that they would like permission for acoustic music on the patio with no amplification that would consist of one guitar player and one singer. It would end before 8pm.

The Board reminded them to keep the doors and windows closed when the amplified music was on inside.

Mr. Donaroma moved to approve the outdoor entertainment as presented and revisit if there were any complaints from neighbors. Mr. Smadbeck seconded. Unanimous.

Ms. Serpa then moved on to the next item which was a request from Behind the Bookstore also for outdoor entertainment. Present was Joyce Sudikoff, Manager and Owner.

Ms. Sudikoff stated that they would also like acoustic music of one guitarist. 3-5 pm and 7-9:30pm.

Mr. Gino Courtney, an abutter, asked if there would be any amplification. He has tenants that sleep very close to the property.

Ms. Sudikoff then responded that they already have speakers outside that play radio music they would use them.

This was news to the Board. They informed Ms. Sudikoff that amplified music outside was not allowed. This included "canned music" such as radio. Acoustic means no speakers.

Mr. Donaroma moved to approve the request for one acoustic guitar player at the specified hours. If there were any complaints from neighbors the issue would immediately be revisited. Mr. Smadbeck seconded. Unanimous.

Ms. Serpa then recognized Ms. Suzan Bellincampi from Felix Neck. They would like an Entertainment License and One Day Liquor License for a fundraiser on August 20, 2019.

Mr. Smadbeck moved to approve. Mr. Donaroma seconded. Unanimous.

The Board then approved the following items:

Performance reviews for Harbormaster Charlie Blair and Shellfish Constable Paul Bagnall. Mr. Hagerty added that Mr. Blair is an asset to the town.

The Board signed the Dukes County Health and Human Services Contract.

For the TV show "Weekends With Yankee" to film the streets with a small crew on August 15th.
