## Selectmen's Meeting November 19, 2018 4:00 pm

A meeting of the Board was held on the above date in the meeting room of Town Hall. Members present were: Michael J. Donaroma, Chairman; Margaret E. Serpa and Arthur Smadbeck. Also present was Town Administrator James Hagerty.

At 4:00pm Mr. Donaroma opened the meeting and the first item on the agenda which was a public hearing for a Change of Liquor License for the Square Rigger to change from an annual to a seasonal liquor license. Present was Jenny Dowd, Manager.

Ms. Dowd explained that it was time to go seasonal.

There being no public comment or correspondence, Mr. Donaroma closed the hearing.

Mr. Donaroma replied that the more visitors they have the better. He asked if docking would be an issue.

Mr. Blair responded that they can make it work and it shouldn't be a problem.

Ms. Serpa moved to approve. Mr. Smadbeck seconded. Unanimous.
