## Selectmen's Meeting August 8, 2016 4:00 pm

A meeting of the Board was held on the above date in the meeting room of Town Hall. Members present were: Margaret E. Serpa, Chairman; and Michael J. Donaroma. Also present was Town Administrator Pamela Dolby.

At 4:00pm Ms. Serpa opened the meeting and the first item on the agenda which was the annual review for Building and Zoning Inspector Lenny Jason. Mr. Jason was present.

Ms. Serpa pointed out that it is a very busy time for his office.

Mr. Donaroma stated that the Board appreciated everything Mr. Jason does.

Ms. Dolby stated that the issues are never ending and solutions never happen as fast as people want them too. Mr. Jason tackles them the best he can.

Mr. Donaroma moved to give Mr. Jason a favorable review. Ms. Serpa seconded. Unanimous.

Ms. Serpa then moved on to the next item on the agenda which were the changes to the Conservation Restriction on Katama Airfield. Present were Conservation Commission Chair and Katama Airfield Member Peter Vincent Jr. and Conservation Agent Jane Varkonda. Also present was Airfield Member Harald Findlay.

Mr. Vincent stated that this was a long time coming. Finally all the hoops with the state have been ironed out. Before them was the final paperwork that clears the way to go forward with building the new hangar.

Mr. Donaroma moved to approve and sign the five documents for the change of conservation restriction. Ms. Serpa seconded. Unanimous.
